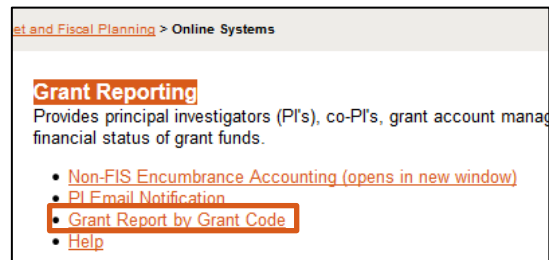

CORE Quick Tips - Grants

Reconciliation of Payroll

NOTE: Activity for current and future months based on the default labor distribution defined in the HR system. Default pay is reported when entered (visible in CORE reports the next day) but **will not** post to Banner Payroll encumbrances until either the Payroll mid-month or end-of-month process.

Pay Reconciliation Report

Notes about Payroll Encumbrances

- Payroll Encumbrances are created at the beginning of the fiscal year and adjusted monthly at the end of the month following posting. They are only adjusted once monthly at the end of the month.
- Any changes to Employee Pay records that occur around/after Encumbrances are adjusted for the current month, will not be reflected until the **next** month.
- If an Employee Record is not set up correctly, the Encumbrance will likely be incorrect. Common errors that affect Encumbrances are:
 1. The Job Record was changed, but the Default Pay was not changed;
 2. There was a Labor Redistribution, but no adjustment was made to the Default Labor Distribution;
 3. An incorrect Account Code was used for either the Job Record or the Default Pay.
- If a discrepancy in an Encumbrance is discovered:
 - Review the Default Pay and make sure it was updated correctly. The Default Pay can be reviewed in the CORE FIN1553 for an Index or PAY1554 for an Employee, or Banner-PYIVERI.
 - If the Default Pay looks correct, locate the date when the change was made. If the change date was **after** Encumbrances were adjusted for the month, it is necessary to wait until the next month for the adjustment to occur.
